Using social media sites is a fun and easy way to connect with people. You can keep in touch with friends and family, share photos and videos, get involved with issues that interest you and play games. It's also a great way to express yourself, tell people what's on your mind and be creative.

What is the 'Easy Guide to Socialising Online'?

The 'Easy Guide to Socialising Online'* provides information about the cybersafety features of different sites, including social networking sites, search engines and online games. You can learn how to adjust your privacy settings, report inappropriate content and find out more about other safety features.

There's also general advice on our Tips page about how you can stay safe online using any social media site – including any that aren't listed here.

How was the Easy Guide developed?

The Easy Guide was developed by experts – including industry partners and Australian teenagers.

It was created in response to advice from the Australian Government **Youth Advisory Group on Cybersafety** (YAG) – a group of young people from all over Australia who provide advice to government on cybersafety issues.

YAG members told us that young people wanted to know more about how to socialise online safely, and that their parents wanted to know more about the sites young people use.

Advice on social media sites was provided directly by social media organisations including Facebook, Google, Microsoft, NineMSN, Yahoo!7 and the Interactive Games and Entertainment Association.

We've also incorporated valuable feedback from members of the YAG and the **Teachers and Parents Advisory Group** on Cybersafety.

tips for socialising socialisine

Look after each other online—talk with your family and friends about how to be cybersafe.

Download the government's Cybersafety Help Button. The Help Button provides internet users, particularly children, with easy online access to cybersafety information and assistance available in Australia.

Think before you post! Posting personal information—including photos—may seem harmless but could put people at risk. Once it's online, it's really hard to take down.

Keep your passwords secret. To make your password really hard to hack make sure it includes numbers and symbols, and change it often. Visit Stay Smart Online for more information.

Smartphones can pinpoint your exact location and publish this online. Think carefully before you check in and tell the world where you are. Learn more at Cybersmart's Geologaters page.

Check if the site has an age limit or rating. Some have age limits to protect you from inappropriate content. Parents can check out Cybersmart's infographic for handy tips on pre-teens that want to join social networking sites.

Use the Cybersafety Help Button to report cyberbullying and inappropriate content directly to social media sites, the ACMA or the Australian Federal Police.

Use the privacy settings to control who can see your personal information. You can also use a site's settings to block users who make you feel uncomfortable

There is no such thing as safe sexting. You could be breaking the law if you send, receive or forward these types of pictures. Learn more at Cybersmart's Sexting page.

Tribute pages dedicated to the memory of a friend or loved one need to be carefully monitored – it can be very upsetting if people make disrespectful or offensive comments on these pages. Carefully manage your page permissions to control who can access and post to the page.

Who can access the site?

Bebo is available to people over the age of 13.

By creating an account, you agree to comply with Bebo's Terms of Service.

How can I protect my information?


Default privacy settings for users aged 13+

By default, Bebo's privacy settings limit the information people can see on your profile. Bebo allows you to adjust your privacy settings to control what information you share and who you share it with.

Adjust your privacy settings

You can adjust your privacy settings to control the following information:

- whether your profile can be seen by everyone or just your friends
 Bebo recommends that if you are under the age of 21, you choose a private profile
- how long you have been a member
- · when you are online
- whether your profile shows up in search results
- who can post comments to your profile
- if all comments and whiteboards are posted to your profile
- if comments and whiteboards from non-friends are reviewed before posting
- if all comments and whiteboards are reviewed before posting
- whether challenges can be received when sent from non-friends and more.



Above is an example of how to adjust Bebo's privacy settings.

To access these settings, you can:

- 1. log into your account
- 2. click Profile in the top tool bar
- 3. click Edit Profile on the left-hand side
- 4. click Privacy Settings.

Editing Photo Albums

By editing your photo albums you can control who can see your individual photo albums and choose whether to allow others to copy photos from photo albums. You can find more information on editing your photo albums at Bebo Help.



Above is an example of how to control who can see your photo albums on Bebo.


How can I report cyberbullying or abuse?

To report abuse, you can:

- 1. log into your account
- 2. navigate to the profile page of the person you wish to report
- 3. click the Report Abuse link located below their profile picture.

To flag a specific photo, video or widgets, you can click the *Report Abuse* link below the content.



Blocking a user

Bebo allows you to block contact from another user. Your profile remains visible to users you have blocked, but prevents them from contacting you.

To block a user, you can:

- 1. log into your account
- 2. navigate to the profile page of the person you wish to block
- 3. click the *Block* link located below their profile picture.

Are there ways to spend money on Bebo?

Bebo is free to join and use.

For a fee, you can purchase *Credits* on Bebo. *Credits* are a virtual currency used to buy virtual goods in games hosted on the Bebo platform. Credits can be purchased using a credit card or PayPal account.

Bing is a search engine that finds and organises the answers you need so you can make informed decisions. Bing can be used to search the web, or search for images, videos, local businesses and more.



Who can access this site?

Bing is available to anyone and has no age restrictions.

If you use Bing, you agree to comply with Microsoft's Service Agreement.

How can I protect my information?

SafeSearch


Bing's SafeSearch tool allows you to block explicit content from being displayed in search results.

Bing's default setting is *moderate*, which automatically blocks search results with adult images and video content. You can also change your setting to *strict* or *off*.

To adjust your SafeSearch settings, you can:

- 1. click Preferences located in the top right-hand corner of Bing's website
- 2. select one of the options in the SafeSearch section
- 3. click Save located in the bottom right-hand corner.

You can change the SafeSearch setting by visiting Bing's Preferences page.




Above is an example of how to adjust Bing's SafeSearch settings.

How can I report cyberbullying or abuse?

If SafeSearch is turned on and you're still receiving adult material or any other content that is offensive in your search results, you can lodge an online support form by following these instructions:

- 1. click on *Help* located in the bottom right hand corner
- 2. click Report a concern located underneath Safety and privacy
- 3. click on Bing Report a Violation Support form
- 4. complete the form
- 5. click Submit.

Club Penguin

Club Penguin is a virtual world where children can play games, interact with friends, attend parties and special events, and participate in creative and imaginative activities.



Who can access this site?

Club Penguin is designed for children aged 6-14 years old, but people of all ages can create an account.

When creating a Club Penguin account, a parent's email address is required. This allows Club Penguin to verify that the child has permission from the parent to use the site.

By creating an account, you agree to comply with Club Penguin's Terms of Use.

How can I protect my information?


Default privacy settings for all ages

By default, you are not able to access other members' personal details.

Safe chat options

In Club Penguin you can choose the most appropriate chat option to help protect your privacy. You are asked to select a suitable chat option each time you log in. The two different chat options you can choose from are:

- Ultimate Safe Chat Allows you to only choose from a menu of pre-approved comments. In this mode you will only see ultimate safe chat messages from other players. To choose an Ultimate Safe Chat world, look for the speech bubble icon when selecting a server.
- Standard Safe Chat Allows you to type your own messages to other users.

Above is an overview of Club Penguin's safe chat options.

Every message is filtered to allow only pre-approved words to be displayed to other players, and to block attempts to communicate problem phrases, a phone number or other personally identifiable information.

How can I report cyberbullying or abuse?

You can click the *M* icon to report any concern that may arise. Club Penguin employs on-site moderators to receive reports of misconduct and monitor activity and chat.

Ignoring another user

Club Penguin allows you to block communications from another users by adding them to an ignore list. To add another user to your ignore list you can click the ghost icon.

www.facebook.com

Facebook is a social networking site that allows members to connect and share with the people, places and things that they care about.



Who can access this site?

Facebook is available to people over the age of 13. Facebook will not create an account for a person who lists their age as under 13.

By creating an account, you agree to comply with Facebook's Statement of Rights and Responsibilities. For a succinct explanation of what can and cannot be posted to Facebook, check out the Community Standards page.

How can I protect my information?

Default privacy settings for users aged 13-17

Basic information you choose to share via the site (such as your name, profile picture and gender) is publicly available. However, by default, you can only share what you post with a maximum audience of the friends of your friends. Even if you change your privacy settings to Public, your information will only be shared with Friends and Friends of Friends. This is different from adults, who can choose to share publicly.

Some things, like your school, address, hometown or birthday may only be visible to your friends, friends of your friends, and/or other minors.

You can choose to limit the audience with whom you share to only your friends, or just some of those friends. The Custom privacy settings allow you to specify who is able and not able to view the content you share. You can choose to share with or exclude specific networks, friends and friend lists. You can also limit some of the information you post on Facebook to *Only Me*.

Public search listings are also unavailable for people aged 13-17. Unlike people aged 18 or over, the details of a person aged 13-17 will not appear in public search engine results. For Graph Search (search within Facebook), like adults, people aged 13-17 can appear in search results. Some information, such as your school, current city, hometown or birthday may only be visible to your friends, or friends of your friends who are also minors. Learn more at Facebook's Graph Search page.

Default privacy settings for users aged 18+

If you create an account aged 18 or over, Facebook's key privacy settings are *Public, Friends, Only Me* and *Custom*. By default, some of your privacy settings are set to Public including your name, profile picture, gender, status updates and photos you post to your profile. Other privacy settings are set to Friends by default including contact information and places you check in to. You can control who can see what you choose to share on Facebook by using the privacy settings.

You can also use Facebook's Custom privacy settings to specify who is able and not able to view the content you share. You can choose to share with or exclude specific networks, friends and friend lists. You can also limit some of the information you post on Facebook to *Only Me*.

An overview of the differences between privacy settings and sharing options for people aged 13-17 and 18+ is available at Facebook's Minors & Privacy page.

Adjusting your default privacy settings for all ages

You can adjust your default privacy settings for the following sections:

- Control Privacy When You Post—you can manage the privacy of your status updates, photos and information through your inline audience selector settings.
- How You Connect—manage how you connect with people you know.
- Timeline and Tagging—what happens when friends tag you or your content, or post on your timeline
- Ads, Apps and Websites—the information you are willing to share with applications, games and websites
- Limit the Audience for Past Posts—you can manage past post visibility
- Blocked People and Apps—manage the people and apps you've blocked.

Privacy shortcuts for key settings on Facebook are available in the toolbar when you log in to your account. To access these privacy settings you can:

- 1. log into your Facebook account
- 2. click the drop down menu with the lock on it in your toolbar
- 3. access the key settings to manage *Who can see my stuff?*, *Who can contact me?* and *How do I stop someone from bothering me?* You can also access Help Center content from the privacy shortcuts.

Profile information settings

Facebook allows you to edit your profile information and control what groups of people (*Public, Friends, Only me* or *Custom*) can view this information. Your profile information includes basic information (for example, location, date of birth, about me) and contact information.

To access and adjust these settings, you can:

- 1. log into your Facebook account
- 2. click on your name located in the top right hand corner
- 3. click on Update Info located underneath your cover photo
- 4. edit your information and/or adjust who can see it by selecting *Public*, *Friends*, *Only me* or *Custom* from the drop down menu located next to the relevant information.

Controlling Privacy When You Post

When posting on Facebook you can choose who sees your status updates, photos and information using Facebook's inline audience selector.

Below is an example of Facebook's *inline audience selector*. The drop down menu (highlighted by the circle) shows you where you can select who can see your posts. The drop down menu will provide you a list of options that includes making the post viewable to the public, friends only, a list of friends you have already created or you can create a new customised list.

Lists


Lists give you an optional way to share a post with a custom audience, or exclude some friends from a post based on how well you know them.

You can choose to share or hide content from one or more of your lists using the *inline audience selector*. For example, you can use Facebook's default lists, including close friends or acquaintances, or you can create custom lists, for family members, work colleagues or team mates.

You can also add people to your *Restricted* list. When you add someone to your *Restricted* list, they will only be able to see your *public content* or your posts that you've tagged them in.

To do this you can:

- 1. log into your Facebook account
- 2. click on Home located in the top right-hand corner
- 3. find the list you want to edit in the left hand column, or click the *More* link next to friends
- 4. select the list you want to edit or click Create a List
- 5. search for your friends in the search bar at the top of the page, or add people from the *List Suggestions* on the right.

Timeline and Activity Loq

Timeline is your collection of the photos, stories, and experiences that tell your story on Facebook. You control who can see what's on your Timeline. For more information about how to do this, check out Facebook's Timeline Privacy page.

You can also see what your timeline looks like to other people by using the View As tool.

- 1. go to your timeline and click on the right, below your cover photo
- 2. click View As... from the dropdown menu
- 3. you'll see what your profile looks to the public. To preview how your profile appears to a specific person, like a friend or coworker, type their name into the open field and press enter.

Keep in mind, posts and photos you've hidden on your timeline are still visible to the audience they're shared with and other places on Facebook, like news feed and search. If you want to manage photos or posts that other people post to Facebook about you, please use the Remove/Request tool in Activity Log (discussed below).

At the top of your Timeline, you have a link to view activity in your private Activity Log. It is a list of everything you've done or posted on Facebook and is only visible to you.

For an overview of all of your posts and activity on Facebook, use Activity Log.

Activity Log lets you easily review your own activity on Facebook, such as your likes and comments, photos of you and posts you've been tagged in. You can also sort information in your Activity Log to quickly see public photos you're tagged in and have hidden from your timeline, but which still appear in other places on Facebook. Only you can see your Activity Log.

You can access your activity log by clicking the Activity Log button on your timeline, under your cover photo.

Adjusting your account security settings

You can adjust your browsing and login security to select browsing via a secure connection (https) whenever possible, or receive a notification when an unrecognised computer tries to access your account.

To adjust your security settings, you can:

- 1. log into your Facebook account
- 2. click on Account Settings from the drop-down menu located in the top right hand corner
- 3. click on Security



Above is an example of Facebook's security settings.

Removing a wall post or story

You can remove anything that you have posted on your Facebook Timeline or anything you have posted on Facebook.

To remove a post, you can:

- 1. hover over the post in question and click the symbol that appears in the top right hand corner of the post
- 2. select *Report/Remove* from the drop down menu.



Above is an example of how to remove a wall post or story on Facebook.

In Activity Log, you also have a Request and Removal tool for taking action on multiple photos you're tagged in. In Activity Log, go to the *Photos of You* tab, select multiple photos, and either untag yourself or ask friends to take down the shots you don't like – you can even include a message about why this is important to you. The tool also lets you untag multiple photos at once, keeping in mind that while untagged photos don't appear on your timeline, they can still appear in other places on Facebook, such as search, news feed, or your friends' timelines.

How can I report cyberbullying or abuse?


The best way to report abusive content on Facebook is by using the Report link that appears near the content itself. Facebook allows you to abusive content for a number of different features, including:

- timelines
- photos and videos
- profiles
- messages
- groups
- events
- pages
- posts
- · something you can't see.

Facebook's How to Report Things page has instructions on how to report abusive content for the different features.

If you have reported something to Facebook you can check the status of this report through your Account Settings. To access your Account Settings, you can:

- 1. log into your Facebook account
- 2. click on Account Settings from the drop-down menu located in the top right hand corner
- 3. click on Support Dashboard.

Social Reporting Tool

If you want to report content you don't like, but it doesn't violate the Facebook Terms, you can use the report links to send a message to the person who posted it instead of reporting it to Facebook. You can also use this feature if you don't want to report the person directly, but would like to ask them to remove the content.

For example, if you are reporting a photo of yourself, you can easily send the person who posted it a message letting them know you don't like it.

To report to a person directly, you can:

- 1. click the *Report story* or *spam* link locked in the top right hand corner of the post in question
- 2. click file a report
- 3. select I don't like this post then click Continue
- 4. you can then select to send a message to the person to remove the post, then click *Continue*.

In cases of bullying or harassment, where you don't feel comfortable reaching out to the person directly, you can use social reporting to get help from a parent, teacher or trusted friend. You can share that piece of content and a message about the situation with someone you trust.

To report to someone you trust, you can:

- click the Report story or spam link locked in the top right hand corner of the post in question
- 2. click file a report
- 3. select It's harassing me or It's harassing a friend then click Continue
- 4. you may then select *Block the person, Get Help from an authority figure or trusted friend* and *Report to Facebook*and click *Continue*
- complete who you would like to send the message too and the message you would like to send to that person then click Continue
- 6. your trusted person will receive an email with a copy of the content you are reporting, along with your message. You also have the option to block the person.

Blocking a user

A block prevents specific people from viewing your profile, and you will not appear in their search results or friend lists. Blocking is mutual, so they will also become invisible to you as well.

To block a user, you can:

- 1. click the account menu in the top right corner and select Privacy Settings
- 2. find the Block Lists section and click Manage Block Lists
- 3. enter the name or email address of the person you want to block and click Block. People will not be notified when you block them.




By default, Flickr's privacy settings are set so most of your information can be seen by everyone. Flickr allows you to adjust your privacy settings to control what information you share, and who you share it with.

Adjust your privacy settings

You can access your privacy settings to control:

- whether the profile is public or private
- what personal information is shared with other Flickr users
- who can see, comment on or add tags to your photos
- who can print your photos
- if other people can share your photos.

You can also specify what privacy level you want (Public, Visible to friends, Visible to family or Private) for photos you upload.

To set your search preferences, you can:

- 1. log into your account
- 2. click the *you* drop-down menu located in the top toolbar and select *Your Account*
- 3. click Privacy and Permissions located in the top tabs
- 4. scroll down to Content filters and click edit
- 5. select a SafeSearch option and click Save Changes.

Flickr states that if enough members flag a photo, they will hide the page from public pages.

Inappropriate content or behaviour that warrants immediate attention can be reported at Flickr's *Report Abuse* page. This link is also available at the bottom of every Flickr page. Flickr asks that you report from the specific page that the offensive content appears on.








Above is an example of how to block a user on Formspring.



How can I protect my information?

Default privacy settings for users aged 13-17

By default, if you are aged 13-17 Google+ limits most of the information on your profile to people in your circles, although some fields like name and photo are public.

Default privacy settings for users aged 18+

By default, if you are aged 18+ most of your profile information is public. Google+ allows you to adjust your privacy settings to control what information you share and who you share it with.

Adjust your privacy settings

To adjust your privacy settings, you can:

- 1. log into your account
- 2. click on Settings located in the top right of the page
- 3. click on Profile and privacy in the left-hand column
- 4. click on Edit visibility on profile.

Sharing and Circles

Circles are groups of people with whom you share content. Circles help you organise people according to real life connections. By organising people into circles you can share relevant content with the right people, and follow content posted by people you find interesting.

If you are aged 13-17 and add Public or Extended Circles to a post, Google+ will remind you who will potentially be able to see your post.

To manage your circles, you can:

- 1. log into your account
- 2. click on Settings located in the top right of the page
- 3. click on Profile and privacy in the left-hand column
- 4. click on Manage circles.

Hangouts

Hangouts lets you connect with people face to face through live video chat on Google+.

If you're aged 13–17 you must consent to hanging out with people who are not in your Circles. When you initially join a hangout, you are consenting to hanging out with everyone who is there. When someone outside your circles joins the conversion Google+ will pull you out and ask you if you want to continue. More information is available at Google+'s Minor Controls in Hangouts page.

If you don't feel comfortable 'hanging out' with someone you can block them. For details of what this means visit Google+'s Blocking People in Hangouts page.

Post and notifications

Google+ has settings to help you control how people can interact with you.

- Who can notify me? lets you decide who can send a notification to you (either via email or the notification widget at the top of your screen).
- 2. Who can comment on my public posts? lets you decide who you want commenting on posts you've sent to Public or Extended Circles.
- 3. If you're aged 13–17, by default both of these settings are set to people in your circles. If you're aged 18+ the default is set to Anyone.

To access these settings, you can:

- 1. log into your account
- 2. click Settings located on the right-hand side of the page
- 3. Click on Google+ on the left-hand navigation panel.



Above is an example of how control how people can interact with you on Google+.

In addition, Lock my post lets you prevent others from resharing your post. When you post on Google+, others are able to reshare your post. If you want to prevent this from happening, you can lock your post. Once a post is locked, others won't be able to reshare it.

To lock your post:

- 1. click the drop down arrow in the box where you choose who to share the post with
- 2. select lock this post
- 3. complete your post and share.

You can lock your post after you share too. Just click the drop down arrow at the top of the post and click lock this post. Keep in mind that this won't retroactively apply locked settings to your post.

Your locked posts will say '(locked)' at the top. If you'd like to unlock your post at a later point, click the drop down arrow at the top of your post and select unlock this post.

Controlling comments

You can remove comments from your own posts that make you feel uncomfortable. To remove a post, hover over the comment in question and click on the grey X that appears on the right.


You can also disable comments completely from a particular post. Click on the menu button in the right-hand corner of your post and select Disable comments.

How can I report cyberbullying or abuse?

If you see content that violates Google+'s User Content and Conduct Policy you can report it directly to Google. These reports are anonymous.

How to report a comment:


- 1. hover over the comment with your mouse
- 2. click on the grey flag that will appear on the right.



Google's SafeSearch tool allows you to manage search results so they do not include sexually explicit websites and images. SafeSearch gives you the choice of three settings - Strict, Moderate or None. By default, SafeSearch is set to Moderate.

To change your SafeSearch settings, you can:

- 1. click on search settings located in the top right-hand corner of the Google site
- 2. scroll down to Safe Search Filtering.


Google's search results are a reflection of web pages on the internet. The websites in Google's search results are controlled by those sites' webmasters. To report inappropriate content in the first instance, you should contact the website operator and request the content be removed.

Google will remove search results from its index when required by applicable law (for example, when linked to content infringing copyright) and in a small number of other instances (for example, spam results).

To report content that you believe should be removed from Google's services, complete the *Removing Content From Google* form. Completing this form will help ensure Google has the necessary information to investigate your specific enquiry and resolve it as quickly as possible. Where feasible, Google will tell you when it has removed search results from its index.

To access this form, you can:

- 1. visit Google's help page at www.google.com.au/help
- 2. type Removing Content From Google form in the search box
- 3. click on the first search result.

Instagram is a way to share your photos with friends and family. Snap a picture, choose a filter to transform its look and feel, then post it to Instagram.



Who can access the site?

Instagram is intended for people over the age of 13. It is not possible to sign up for an Instagram account on the website. You need to sign up for an account within the Apple or Android app.

By creating an account, you agree to comply with Instagram's Terms of Use.

How can I protect my information?

Default privacy settings for users aged 13+

By default, anyone can view your profile on Instagram or the Instagram.com website. If you do not wish to share your profile, you can set your photos to private and your photos will be visible only to those users you've allowed to follow you.

Some profile information is not visible to anyone but you. This includes your email address, phone number, sex and birthday.

Adjust your privacy settings

To make your profile private, you can:

- 1. tap the far right address card icon to go to your profile
- 2. tap the settings icon in the upper right icon
- 3. **Apple device**—scroll to Photos are private and toggle the switch to ON to turn on privacy.













- 3. Kik will work with law enforcement where appropriate and to the extent required by law to ensure the safety of all users.

Who can use it?

Any Wii U owner can access Miiverse on their Wii U system. In addition, Wii U owners can also connect to Miiverse on PCs, smartphones and other devices by going to miiverse.nintendo.net and logging in with their existing Nintendo Network ID and password.

Use of Wii U online, including the use of Miiverse, is subject to the Nintendo Network Agreement and the Nintendo Network Privacy Policy. If you are under 18, you must get a parent or legal guardian to read and accept these on your behalf. The Wii U system should be set up by an adult. Use of Miiverse is also subject to the Miiverse Code of Conduct.


How can I protect my information?

Parent Controls

Wii U has parental control settings that enable parents and guardians to restrict certain Wii U content and features on a per user basis. The parental control settings relevant to Miiverse are:

- The Miiverse setting can be used to restrict the viewing and posting of content on Miiverse. Please be aware that this parental control setting on the Wii U system cannot restrict the use of Miiverse on a PC, smartphone or other device.
- Restrict the registration of friends with the *Friend Registration* control.

Additionally, some functions allow communication with users who are not registered friends. This can be restricted by activating the Online Interaction in Games and Internet Browser restrictions.

- 2. if prompted, tap Next and enter the four-digit PIN
- 3. select Parental Controls Settings
- 4. you can set different restrictions for each user
- 5. tap *OK*
- 6. select the user for which you wish to set restrictions
- 7. scroll down and tap Miiverse
- 8. tap the desired restriction
- 9. to allow use of Miiverse, tap Do Not Restrict
- 10. to prevent the user from posting text or images, but allow them to view posts from other users, select *Restrict Posting Only*
- 11. to prevent all access to Miiverse features, tap Restrict Viewing and Posting
- 12. tap *OK*
- 13. tap Save, or press the B Button to confirm the settings
- 14. tap Save
- 15. tap *OK*.

Miiverse Settings

In addition to using parental controls, you can also adjust specific Miiverse settings on your Wii U system to manage your Miiverse experience:

- You can choose which of the following types of information will be visible to other Miiverse users:
 - Your profile comment

 - Your birth day and month
 - · Your friends list, followers and followed users.
- You can choose whether to receive friend requests if you are over the age of 12. If you are aged 12 or younger

Miiverse Friends

Choose Miiverse friends wisely. Friend registrations can be restricted by the Wii U system's Parental Controls. For the protection of younger users, friend requests are not possible in Miiverse for users aged 12 and under. Users aged 12 and under can make friends on Wii U outside Miiverse by entering each other's Nintendo Network IDs in the Friend List on the Wii U Menu.

Younger users are encouraged to make friends on Wii U only if they are friends in real life (such as friends from the same school or neighbourhood). They should not attempt to exchange their Nintendo Network IDs with other users on Miiverse.

Miiverse Code of Conduct

All people who use Miiverse are bound to comply with the Miiverse Code of Conduct. Harassment of any kind, including slander, defamation of another user, disclosure of personal information or invasion of privacy, is a violation of the Miiverse Code of Conduct. Even in messages between friends, such exchanges violate the Miiverse Code of Conduct.

If you are experiencing harassment, you can use the Report function on the offending user's profile screen. Please report any posts or messages that violate the Miiverse Code of Conduct.

Reported violations will be reviewed by a Nintendo moderator. Any post that violates the Miiverse Code of Conduct will be removed.

If you see content that presents a credible risk to your or another's safety, please contact the Australian Police by phoning 000. If contacted by the Police or other law enforcement agency, Nintendo will work with them directly on their investigation.

Blocking a User

Blocking a user in Miiverse will prevent that user from sending you friend requests and they will also be unable to comment on your posts. To block a user, you can select *Block* from the user's profile screen.

Defriending a user

To defriend someone, you can select remove friend within the Friend List.

Within Miiverse, you can go to the friend's profile screen, select *friend* and then select *remove friend* under the pull-down menu.



How can I protect my information?

Default privacy settings for all ages

By default, if you are playing a demo version of Minecraft your email address will be displayed instead of a username. If you are playing with a paid version of Minecraft, your username, age and country location can be seen by other players in the game.

If you do not want to share any information with other players, you may choose to create and/or play on a private server. This is called whitelisting.

How can I report cyberbullying or abuse?

Minecraft are unable to moderate player behavior or server content. All servers are privately run, and players are responsible for their actions server to server.

If you are having trouble on your server, Minecraft suggest researching anti-griefing mods, and whitelisting your server so that only selected people are allowed to play. Adjust your privacy settings

Users can create a digital character (known as a Mii) to represent themselves when playing games on the 3DS or 3DS XL. Who can use it?

Nintendo 3DS is recommended for people over the age of 7. However, anyone can use Nintendo 3DS in 2D mode.

By using the Nintendo 3DS, you agree to comply with Nintendo's 3DS User Agreement. If you are under 18 years of age, you must get a parent or legal guardian to read and accept this agreement on your behalf.

How can I protect my information?

Parental Controls

The Nintendo 3DS and Nintendo 3DS XL has parental control settings that allow you to limit access to certain services and content that you may deem unsuitable for minors. You can:

- restrict the use of Nintendo 3DS based on ratings from the Classification Board
- restrict the display of 3D images
- restrict the use of the internet browser



PictoChat

PictoChat allows users to communicate wirelessly with other Nintendo DS and Nintendo DS Lite users within a range of approximately 20 metres (65 feet). Up to 16 users can chat at one time in a PictoChat chat room. In addition, some games may also have similar chat features programmed into the game.

There are no controls to monitor or restrict this feature. Messages may be received by strangers and communicated from strangers.

To ensure your privacy do not give out your personal information such as last name, phone number, age, email or home address when communicating with others.

Children who use Nintendo DS should be warned against communicating with or meeting strangers or communicating personal information which strangers may receive and read.

The date the user enters as their month/day of birth (year is not asked for) will be communicated via a birthday message in the chat room on that date. Whatever name the user enters as their nickname during the system set up can be viewed by other Nintendo DS users while using PictoChat. An adult should assist children with the system setup.

Multiplayer gaming and Wi-Fi connection games

With the Nintendo DS, you can link up with other gamers for multiplayer action. Some games are designed so that only one player needs a game in their system – everyone else simply downloads it from player one. Current games allow multiplayer action with other players who are in the same area as you (within approximately 20 metres).



To set up the Parental Controls, you can:









The PlayStation®Network is an interactive environment for PlayStation 3, PlayStation Vita and PSP. On the PlayStation Network you can play online games, chat to friends and family around the world and surf the web. It also gives you access to entertainment content such as downloadable games, catch up TV, movie and music services and more.



Who can access the site?

Anyone can create a PlayStation® Network account. Children under 18 may only hold a Sub Account, which must be associated with a PlayStation® Network Master Account held by a parent or legal guardian. When you create a PlayStation® Network account, you join the Sony® Entertainment Network.

To learn how to set up a PlayStation® Network Master Account and then a Sub Account for your PlayStation 3 you can visit PlayStation® Network's Signing-up for Playstation® Network page. You can also learn how to sign up your PlayStation® Vita to the PlayStation® Network.

By creating an account, you agree to comply with PlayStation® Network's Terms of Use.

How can I protect my information?

Online ID

When you create a Master (over the age of 18) or Sub Account (under the age of 18), you may choose an Online ID. Your Online ID is your public nickname while you are using PlayStation Network and may be visible to all PlayStation Network users. Other users can send you messages or chat if they enter your Online ID into the message/chat feature (listed under Friends). If you accept other users as your Friends in PlayStation Network, they can see what you are accessing on your console at any time.


Your online activity, including your Online ID and public statements, may be recorded and distributed outside PlayStation Network by Sony, or by other users. It is recommended you don't include any information which could be used to identify you in your Online ID or other public statements.

Parental controls

If you hold a Master account that is associated with a Sub Account the PlayStation Network has Parental Controls to help you manage the Sub Account holder's online activities.

Content Restrictions

When a Sub Account is set up for a child on the PlayStation Network you will be asked to confirm their date of birth. Children with Sub Accounts will not be able to purchase content (games, comics and videos) from the PlayStation Store or play any PlayStation 3 format software that is rated above their registered age. However, once content has been downloaded from the PlayStation store to a PlayStation Vita, PlayStation Portable, or PlayStation 3, children may be able to access the content if the parental controls level on the PlayStation Vita, PSP or PlayStation 3 is not set.

Chat

By default, the chat feature on a sub account is set to Block. This means sub account holders are not able to participate in text or voice/video chat with other PlayStation Network users. However, they still can send and receive Message Box messages and chat invitations from other PlayStation Network users.

Internet access can be switched off by the Master Account.

Adjusting Parental Controls

If you hold a Master Account you can adjust the parental controls for a Sub Account. To do this you can:

- 1. Log into PlayStation Network
- 2. Follow the links to PlayStation Network, Account Management, Sub Account Management and Parental Control
- 3. Adjust your settings.



Second Life is a 3D virtual world created by its users. Second Life users can create, buy, and sell anything they can imagine, socialise with people around the world and enjoy live events and gaming activities.



Who can access Second Life?

Second Life is available to people over the age of 16. Second Life will not create an account for anyone who lists their age as under 16.

Second Life includes designated regions which are restricted by maturity:

- Users under 18 can only access general content.
- Users over 18 can access moderate content.
- Users over 18 that have verified their accounts can access adult content.

Educational organisations can develop personal regions in Second Life. These organisations can bring 13-15 year-olds into the virtual world, but they are limited to the spaces owned by those organisations.

By default, Secondlife's privacy settings are set so most of your information can be seen by everyone. Secondlife allows you to adjust your privacy settings to control what information you share, and who you share it with.

- your character (avatar)
- real life identity
- interests
- groups you belong to in Second Life
- favourite locations in Second Life.

You can report violations of the Community Standards using the Abuse Reporter tool located under the *Help* menu in Second Life Viewer (the software used to access Second Life). Second Life reviews these abuse reports; the identity of the reporter is kept strictly confidential.

Blocking a user or object

Second Life allows you to block communication from a user or object:

- User—you can right click on the user's avatar and choose block.
- Object—you can right click on the object, select manage then block.

Who can access this site?


By downloading and using the Skype software, you agree to comply with Skype's Terms of Use and Privacy Policy. You are required to be of legal age to form a binding agreement with Skype.

How can I protect my information?

Default privacy settings for users under 16

By default, Skype has special privacy settings if you are under 16:

- Only allowing people in your contact list to contact you.
 This contact includes all forms of communication using Skype, such as calls, chat messages, video and screen sharing.
- Hiding your age, date of birth and gender on your profile page, so others cannot see this information.
- Hiding your details from search results unless returned as an exact match by Skype Name or email.

If you are aged 16 or over, your account is set so anyone on Skype can contact you.

Snapchat is a mobile application that allows users to capture pictures and videos and send them as messages to other Snapchat users. Every Snapchat message has a viewing time limit ranging from 1 to 10 seconds, as selected by the sender. The timer starts when the recipient views the message. When the time limit is reached, the message is deleted and can no longer be viewed using Snapchat.



Who can access this site?

Snapchat is intended for people over the age of 13. If you are aged 13-17 years old, you should seek permission from a parent or legal guardian before using Snapchat.

By creating an account, you agree to comply with Snapchat's Terms of Use.

How can I protect my information?

Default privacy settings for users aged 13+


By default, anyone who knows your username can send you a message.

In order to message someone on Snapchat, you need to know their username and add them to your My Friends list.

Adjusting your privacy settings

You can configure your Snapchat profile to only receive messages from users on your *My Friends* list. To adjust this setting, you can:

- 1. open the Snapchat application
- 2. tap the square button on the bottom right corner of the screen
- 3. select Settings
- 4. select Who Can Send me Snaps

Saving Snapchat messages

Prior to transmitting a message, the sender is able to save a copy of the image they have composed. After sending a message, the sender can no longer view it through the Snapchat application.

Although the ability to save received messages is not part of the Snapchat application, it may be possible for recipients to use built-in features of the Android and Apple iOS operating systems to take a screenshot or screencapture. It is also possible to use a second device to take a picture of the message as it displays on the screen.

Snapchat attempts to detect if a recipient takes a screenshot or screen-capture and sends a notification to the sender when possible.

If you receive an unwanted, sexually explicit message or are the subject of harassment you can report it by sending an email to support@snapchat.com. Please be sure to include:


- Recipients username (you)
- Sender's username
- Ages of the users involved (if known)
- Time and Date of message(s)
- Nature of the Message(s)

Blocking and Deleting a User



When a person under the age of 13 attempts to register a Stardoll account, a message stating *permission required from parent* will be shown. Stardoll will ask for a parent's email address to verify permission to create the account.

If you are under 13 you are automatically allocated a Kid Safe membership.

- · access other users' written content



By default, anyone can view your Steam profile. However, only your Steam friends can leave comments on your page.

Adjusting your privacy settings

You can adjust your privacy settings for the following sections:

- Profile Status—you can choose whether your profile is viewable by the public, only other Steam users, only your friends, friends of friends, or only you can view it.
- Comment Permissions—you can choose who is allowed to leave comments on your profile page. You can select anyone, only your friends, or only yourself.





Twitter is a real-time information network that allows users to find information streams they like and 'follow' the conversation. Information is presented in short bursts of information called tweets, which are limited to 140 characters or less.



Who can access this site?

Twitter is intended for people over the age of 13, but people of all ages can create an account.

If a parent becomes aware that their child has provided Twitter with personal information without their consent, the parent may contact Twitter at privacy@twitter.com. Twitter states that it does not knowingly collect personal information from children under 13, and if it becomes aware that a child under 13 has provided personal information, it takes steps to remove such information and terminate the child's account.

By creating an account, you agree to comply with Twitter's Terms of Service.

How can I protect my information?

Default privacy settings for users aged 13+

By default, Twitter's privacy settings are set so most of your information can be seen by everyone. Twitter allows you to adjust your privacy settings to control what information you share, and who you share it with.

Adjust your privacy settings

You can adjust your privacy settings to select a protected account, which puts the following restrictions in place:

- people will have to request to follow you and each follow request requires approval
- your profile and tweets will only be visible to users you've approved
- protected profile tweets will not appear in Twitter search
- @replies sent to people who aren't following you will not be seen
- your static page's URL cannot be shared with non-followers.

To access these settings, you can:

- 1. log into your account
- 2. select *Settings* in the drop down menu located in the top right-hand corner of the page
- 3. scroll down and select the Protect my tweets box
- 4. click Save.



How can I protect my information?

Parental Controls

The Wii has parental control settings that allow you to limit access to certain services and content that you may deem unsuitable for minors.

If you use the Wii online you can place limitations on the following features:

- Internet Channel if you have downloaded the Opera browser (subject to availability) via the Wii Shop Channel, it is possible to allow or restrict use of the browser
- News Channel you can control access to the News Channel
- Online Communication and User Created Content you can control the sending and receiving of messages from the Wii console in online games where open communication is available, and also control the exchange of user created content in compatible games and channels (e.g. Wii Message Board, Check Mii Out Channel)
- Use of Points you can control the use of Wii Points, which are used to purchase games and content from the Wii Shop Channel if this setting is on, you will be required to enter the 4-digit PIN to use Wii Points to download items from the Wii Shop Channel

To access these controls, you can:

- 1. access the Wii System Settings
- 2. select the blue arrow to reach the Wii System Settings 2 menu options
- 3. select Parental Controls and select Yes
- 4. enter the 4-digit PIN and select OK if you have forgotten the PIN, select *I forgot* to answer the secret question.

Who can use it?

Anyone can use Wii U.

By using Wii U online, you agree to comply with the Nintendo Network Agreement and the Nintendo Network Privacy Policy. If you are under 18, you must get a parent or legal guardian to read and accept these on your behalf. The Wii U console should be set up by an adult.

How can I protect my information?

Parental Controls

Wii U has parental control settings that enable you to restrict the download and use of certain Wii U content and features on a per user basis. You can place limitations on the following features:

- the Game Rating control restricts the use or purchase of software containing content inappropriate for children, based on Australian classification markings.
- the Online Interaction in Games setting restricts the ability of Wii U software to connect to the internet for activities such as online play and chat.
- · restrict web browsing by blocking access to the internet browser.
- Wii U Shopping Services restricts the use of credit cards and purchase of software in services such as Nintendo eShop.
- Milverse settings restrict the viewing and posting of content on Milverse*.
- restrict the registration of friends and the visibility of your profile information with the Friend Registration control.
- restrict the viewing of internet-distributed videos with the Viewing Distributed Videos settings.
- the Data Management settings restrict the Wii U data management feature.
- Internet Settings restrict the ability to configure internet connection settings.

To access these controls, you can:

- 1. from the Wii U Menu, select *Parental Controls*
- Read the information on the screen, then tap *Next* or press the A Button to continue
- 3. tap Next or press the A Button
- 4. create a four-digit PIN, and then tap OK
- enter the four-digit PIN again to confirm, and then tap OK
- 6. tap OK to select a secret question
- 7. select your secret question from the list
- 8. use the on-screen keyboard to type in the answer to your secret question and tap *OK*
- tap OK to confirm the answer to your secret question
- 10. tap *OK*
- you can register an e-mail address to reset your four-digit PIN should you forget it. Tap Next or press the A Button
- 12. if you don't want to register an e-mail address, tap *No E-mail Address* or press the X Button
- 13. tap *OK*
- 14. use the on-screen keyboard to enter in a valid e-mail address and tap *OK*
- 15. enter in your e-mail address one more time to confirm it, and then tap *OK*
- 16. a confirmation e-mail will be sent to the registered e-mail address
- 17. you may now adjust the parental controls settings.

Miiverse

*Miiverse is Nintendo's online gaming community that lets players around the world use their personalised Mii characters to share experiences, discuss games, post community messages, and discover new content. Players who enter Miiverse will see games, applications or entertainment content of interest to them or their friends.

Choose Wii U friends wisely. Friend connections can be restricted by the Wii U system's Parental Controls. Users can establish a friend connection by exchanging Network IDs outside of the system and mutually agreeing to be friends.

People of all ages can play World of Warcraft. If you are under the age of 13, you can only play using your parent or guardian's account.

By creating an account, you agree to comply with Battle.net's Terms of Use. If you are under the age of 18, you also agree and acknowledge that a parent or guardian has reviewed and accepted the Terms of Use on your behalf.


How can I protect my information?

Parental controls

World of Warcraft has parental controls that help you monitor and manage a child's access to the game. You can control:

- Play-time Limits The daily or weekly hours your child is allowed to play World of Warcraft.
- Play Schedules You can create customised play-time schedules. For example, you can set a schedule so your child can only play afterschool and on weekends or weekends only.
- Real ID Enabling Real ID gives your child access to additional social features, including cross-game chat.
 If Real ID is activated, the real name associated with the account (yours or your child's) will be visible to others.
- Voice Chat World of Warcraft has built-in voice chat. You can manage your child's access to voice chat, by selecting from either Listen and Speak or Listen Only.
- Play-Time Reports You can choose to receive Play-Time Reports delivered to your email address each week.
 These reports include details on a child's play time, including login and logout times and the duration of each play session.

Real ID

Real ID is an optional feature designed to connect players across Blizzard games, including World of Warcraft. To learn more about these features visit Battle.net's Real ID page.

By default, if you use Real ID:

- accepted friends and friends of friends can see your first and last name
- no one can see your account name (your email address)
- friends can see your online status
- friends can see your rich presence information (what you are doing in World of Warcraft and other Blizzard Entertainment games)
- friends can see your broadcasted messages
- friends can see which characters and games you are playing across supported Blizzard games.

You can adjust your Real ID settings via Battle.net's Account Management or the Parental Controls system.

How can I report cyberbullying or abuse?

To report abuse directly to World of Warcraft's support staff, you can right click on the person's name in chat or right click the player's portrait, and select the option to Report Player

Mature Language Filter

Under the Interface Options, Social Settings, you can enable the Mature Language Filter. This selection automatically censors any profanity.

Ignore the player

If you right-click on a player's name in chat, you can select the *Ignore* option. This adds them to your ignore list, and prevents any messages from that character reaching you. To remove someone from your ignore list, open your social pane (Default: O), and select the *Ignore* tab at the top. This shows your currently ignored players and allows you to adjust the list.

Leave the channel

Should you wish to remove yourself from a chat channel entirely, simply type //eave X, where X is the number of the channel you're in. For example, if your chat window shows '[1. General] [Spammer]: I like to spam a lot!', you'd remove yourself from that channel by typing '/leave 1'.

Report spam

If one or more players are spamming a chat channel repeatedly, you can right-click their name and select *Report Spam*. This feature temporarily ignores them for a set amount of time and automatically forwards the reported chat to Blizzard Entertainment's support team for further review. If a player is severely disrupting a channel, Blizzard Entertainment advises this is the most efficient way of bringing the matter to the attention of staff. This feature is for use within game spam, as opposed to personal or public harassment.

Are there ways to spend money on World of Warcraft?

Once you've purchased the game, you can create an online account that gives you free play time for an initial 30 day period. To continue playing after 30 days you need to purchase a subscription. Subscription can be purchased using a credit card, PayPal, Prepaid Game Card or Payment One.






Above is an example of how to report cyberbullying or abuse on Xbox LIVE.







By default, videos that you upload can be seen by anyone. If you upload a video, YouTube allows you to limit the exposure of that video by making it private.

Adjust your privacy settings

If a video is set to private, only the uploader and invited YouTube users can view the video. If a video is set to unlisted, then only users that have the link to the video will be able to see it. *Private and Unlisted* videos will not appear in search results.



YouTube Safety mode

Safety Mode on YouTube is an opt-in setting that can help screen out potentially objectionable content. YouTube uses community flagging and other content signals to filter out inappropriate content.

- 1. click on Safety Mode located at the bottom of the YouTube page
- 2. adjust the relevant settings within the pop-up box.


You can control which comments appear on your videos. YouTube offers the following three options:

- all comments can be posted without approval (default setting)
- · comments can be turned off all together.

- 2. go to My Videos and click on Edit Video Info under the video you wish to edit
- 3. select one of the three options

How can I report cyberbullying or abuse?


You can report content that violates YouTube's Community Guidelines by flagging it. Flagging videos does not take them down straight away, but sends a report back to YouTube staff to review the flagged video.

To flag a video, you can:

- 1. log into your account
- 2. navigate to the page the video is hosted on
- 3. click the flag button located under the video player
- 4. select a reason from the drop-down menu and then click flag this video.

Blocking a user

You can block users from making comments on your videos or sending you messages. To block a user, you can:

- 1. log into your account
- 2. navigate to the profile you wish to block
- 3. click the Block User button in the Connect with box.
